The Company completed the first procedure in a patient utilizing its $LIBERTY^{(B)}$ Endovascular Robotic Surgical System at Baptist Hospital of Miami, which includes Miami Cardiac & Vascular Institute and Miami Cancer Institute. The procedure took place as part of the Company's pivotal human clinical trial, which is part of the Investigational Device Exemption for LIBERTY^(B), and the Company expects its results will support the future submission to the FDA and subsequent commercialization.
